## **General Terms and Conditions**

1. Applicant will come for interview at own cost.
2. Applicant will have to furnish details of the products to be sold in the enclosed format.
3. Applicant will have to bring sample products at the time of interview. Products not so brought and products rejected by the Panchayat Peth Committee cannot be sold on the stall.
4. The product should have a label containing name of the manufacturer / stall holder and price.
5. Stallholders selling food products / snacks, etc. should hold a valid licence from FSSAI if annual turnover is above Rs.12 lacs. If the annual turnover is less than Rs.12 lacs, he/she should hold a registration certificate for the said business.
6. Our representatives may pay a surprise visit to the unit of the stallholder.
7. Grahak Panchayat Peth is neither an exhibition, nor a SALE. The stallholder must remember that it is an activity to ensure sale of quality products at reasonable prices.
8. Please enclose sample of printed Triplicate Receipt with application.
9. Application will not be considered if found incomplete.
10. The product to be sold in Grahak Panchayat Peth must be of good quality and at reasonable price.
11. The product must be INDIAN. Any China Made like product must not be sold in the Peth.
12. Panchayat Peth Committee reserves the rights such as to call for interview, allotment of stall, etc. and the committee is not bound to submit any explanation for the same to the stall holders.
13. The stallholder selected by the Committee for Panchayat Peth will have to pay the full rent by cheque. Please note that no Post Dated cheques will be accepted.
14. If the product is found defective, or if the purchaser wants to exchange the product for some valid reason, or does not want the same, the stall holder will have to act accordingly by exchanging the product or by returning the price to the purchaser on production of original receipt within such period depending upon the nature of the product. The Bill Book of the stall holder must not contain any clause like Goods once sold will not be taken back.
15. The stallholder will produce to the Head of Panchayat Peth Committee official receipt for payment of any type of duty or local body tax.
16. The Head of Panchayat Peth has the right to cancel the stall allotment of any stallholder behaving against the rules.
17. Applications will be accepted in the office of Mumbai Grahak Panchayat upto 20<sup>th</sup> April, 2017.
